Fee-Based vs Fee-Only Financial Planners in Minnesota

While a fee-based structure does create some potential conflict, many fee-based investment firms are also fiduciaries, which often counteracts the potential for conflict.

As a fiduciary, a financial advisor or firm in Minnesota is legally responsible to fully disclose any conflicts of interest and are required to put the interests of their clients ahead of their own.
